Cookie Policy

1.1 Introduction

This Cookie Policy explains how we, newITera, use cookies on our website <https://www.newitera.nl>. We take the protection of your data seriously and ensure compliance with applicable legislation, such as the General Data Protection Regulation (GDPR) and ISO 27001 standards for information security. By using our website, you consent to the use of cookies as described in this policy.

1.2 What are cookies?

Cookies are small text files that are stored on your computer, smartphone or other device when you visit our website. Cookies contain information that is used to improve your interactions with the website and make it easier to use.

1.3 What cookies do we use?

We use the following types of cookies:

Strictly necessary cookies

These cookies are essential to the functioning of the website and cannot be disabled in our systems. They are usually set only in response to actions you perform, such as filling out forms or adjusting privacy settings.

Functional cookies

These cookies enable the website to remember choices (such as your language preference) and provide enhanced, personalized features. They are also used to improve website performance.

Analytical cookies

These cookies help us understand how visitors use our website, such as which pages are visited most often. This information helps us improve and optimize the user experience. For example, we use Google Analytics to collect this data.

Marketing cookies

These cookies are used to show you relevant ads based on your interests. They are often set by third-party advertising systems.

1.4 Why do we use cookies?

The cookies we use serve several purposes, including:

- Improving the functionality of our website.
- Analyzing website usage to optimize the user experience.
- Personalizing content and advertisements for our visitors.





- Collecting statistical data for reporting and to improve our website.
